- · The consignor warrants that all items listed on the this form (or attached) are his/her property.
- · Prophet River Firearms has the exclusive right to advertise, photograph and sell the items listed.
- Prophet River Firearms will decide with the consignor on a starting price. It is in everyone's best interest to price the items at fair market value to sell in a short time frame. If an item does not sell, they can be reduced to a minimum sell price as agreed upon. It is in everyone's best interest to strive to get the highest possible price for the items. Upon sale of any property, the consignor shall receive the agreed upon percentage of the selling price of the merchandise less any applicable fees and/or charges as stated in these Terms and Conditions.
- Any property accepted by Prophet River Firearms from the consignor must be in clean and saleable condition. Any and all costs to bring items up to clean and saleable condition can be charged to the consigner.
- The consignor specifically agrees to indemnify and save Prophet River Firearms harmless from any and all liability, claims, demands, damages, and costs arising by virtue of Prophet River Firearms merchandising, selling or delivering the aforementioned merchandise, including but not limited to liability, claims, demands, damages or costs caused by breech of actual or implied warranties, negligence, or unintentional or negligent misrepresentation, by the consignor, or by Prophet River Firearms, its agents or employees.
- Prophet River Firearms is not responsible for any damage or theft to the property while left on consignment. Prophet River Firearms, its agents or employees is not responsible for any loss or damage to merchandise caused by handling. It is further understood and agreed as one of the considerations upon which Prophet River Firearms accepts the merchandise and in the absence of which Prophet River Firearms would not enter into this agreement, that Prophet River Firearms assumes no responsibility and is hereby relieved from any and all liability, claims or charges in the event of loss of merchandise by reason of fire, theft, burglary, natural disaster or for any other cause and if any or all of merchandise is lost as a result of shoplifting or otherwise, the consignor agrees to accept From Prophet River Firearms' statement of fact as to such loss and consignor does hereby expressly waive any claims for loss of merchandise from any cause whatsoever.
- The consignor may take the merchandise back into his/her possession at any time before a sale is made thus terminating the contract with the understanding that a \$50 fee may be charged to cover the expenses of listing the merchandise. If charged, fee will be due before item(s) are returned. Prophet River Firearms reserves the right to refuse/return any consign items at their discretion.

Consignment Rate, Fees and Payment Terms



- Fees: All consignment payouts and returns are subject to a minimum \$50 processing fee.
- Rates: The consignment payout rate will be determined by the amount of the final sale price. \$1 \$999.99 will result in the consignor receiving 70% of the sale proceeds (* Prophet River will retain a minimum \$50 of the proceeds). \$1000 and over will result in the consigner receiving 85% of the sale proceeds. The consignor also has the option of choosing "In Store Credit". If the consignor chooses this option, then the full value of the sale (minus a \$25 processing fee) will be given to the consignor in the form of a gift card.
- Payment Terms: All consignment payouts will be issued via cheque, two weeks from the sale completion date. This is to accommodate Prophet River's "Non-Firing Inspection Period" on all consignment sales.
